Is this your first grandbaby? Yes.

Share with me what job you do in the plant.

Okay... well... okay. I started in the plant in 1977. Michigan truck plant, that is my base plant. Okay, so um... I'm starting from the beginning you know. So um, I worked days for 90 days, then I went on afternoons. I was working the afternoon shift in 1980 and they laid the afternoon shift off. So, we was, well, I was like uh, back and

forth to Wayne Assembly you know. They had me working like uh... 89 days inspector you know. for one year. Then they laid me off for another year. So, you know, I was off and on for like I worked 60 days. off again, 4 months, off again, you know in between then. Ι wasn't married then. So when I went back to the car plant I met my husband. He was there, my husband. After being laid off and everything I met him. We was talking it over you know, and my last foreman said I should marry him. So yea, I married him. So I got married in 1982. Okay, so I was laid off like um... for about two years beofre I went back in 1985, you know. No - 1984 I was laid off two years. So I went back to the truck plant they hired me in uh as uh what is it, uh, they hired me in as a watershield. Puttin' the paper on the door in trim department.

What is it called?

Watershield job. So when I went in, uh, they trained me... you know, showed me the job I have to do. No - first they put me on the I.V. job pulling those I.V.'s you know, the wires and stuff out. So my friend say no Billie Jean I don't think you can that 'cause your breast are in the way. I said yea well I'll have to talk to Dick or somebody 'cause I don't think I'm gonna like this. So he talked to Dick and Dick took me up to the Watershield job. So, uh. they trained me.

Q What exactly is the Watershield job?

The Watershield job is like the right door... the passenger door side. Okay it is a billup. The first time I was doing it, I was putting this sealer on the door with a sealer gun. Then I would take a sheet of

paper... well Watershield paper, put it on the door - fit it on the door, tear a piece of tape, put it down at the bottom of it, seal it up. Then I take the door handle, shake the door handle and then I will pull a rubber strip over the door.

What did you find hard about that job?

What I found hard about it was puttin' that sealer on the door. Because every day I was messed up with that black stuff you know. Then while I was learning it, it was really a mess, you know... until I got the hang of it and everything. Oh, and I put it on the tailgate.

Yes. So that was the hard part about it. You know, and the jobs started coming you know... doing that. So, uh, they laid me off in 1985. January 11, 1985.. So I was off a year and three months. I had drew all of my unemplyoyment and everything.

How much did you get in unemployment? Did you get sub pay too? Yea, sub pay. It be nice, not to bad. So I went back to work. They called me back to work in 1986. February, 1986, and put me right back on the Watershield job you know. And I couldn't understand why, but you know, who was to question. I was glad to get back. So, uh, when I went back, I worked all the way up to changeover. They put in a new machine. They took the sealer gun out and they put the new machine in it like the robot.

Explain that to me. What do you mean? Okay. This machine, okay, it sits on my side. It can load the paper up and it's some kind of sticky chemical taking the place of the sealer stuff you know. So, um, they put in the machine and as I mash this button, the glass will go down, and this sticky stuff will go all around the paper and it will come up then I just take the sheet out and put it on the door. So that's a little better.

Why is it better?

Because I don't have to deal with grabbing the sealer gun and, uh, puttin' that stuff in and plus you don't have to worry about a mess from that stuff. So, you know, that is fantastic, that was beautiful. Now the job is a little better, but you know how they is. They figure they took off one thing and put something else on there you know. Because they took the tailgate off and they gave us the map pocket. The map pocket is something like a little glove compartment, to put maps and something in. So, uh, it's still the same. Do you have to run on the job? Do you work pretty steady?

Well, I'm not gonna run on a job.

What do you mean?.. If the jobs are coming fast, don't you run? No. I let it go.

You let it go?

Yes. I mean, you know, I told my foreman what my committee man told He said, do not run on the job. That's the main thing I keep in me. the back of my head. Work at my pace, you know, steady working pace. I do not run on the job. I used to because I used to try to, um, like the fellow that worked on the other side, I was trying to keep up with him, but I just realized he's been doing this job for 10 years, you know what I am saying? It is natural to him, you know, this is

something new to me 'cause I have been on like two years. So I started doing it, then I saw it was so uncomfortable for me, so I stopped, and worked at my own pace, you know, a steady pace. So... when Dick found out I was doing that, so he took me off the job. I couldn't keep it up, he probably was still keeping it up, but it was hurting him too, you know. So now I am working my steady pace, you know. If I don't put enough piping on... you know.

Q Who gets it? What happens?

A Well, the repairman gets it, you know. Well, Clifford gets it, if don't get it, it will go all the way then they will send someone else over to the other side and they'll get it. It don't be too many, it probably be one to two. It all depends how many map pockets they receive in a row. Sometimes you have three, you know, trucks in there that doesn't call for map pocket. So it all depends how many they, you know, send in. Sometimes there can be like 21 in the room.

Q So that's when you might fall behind?

A Yea, fall behind.

Q So you work with the robot now, you work at your own pace still. Do you think that the robot has added to the quality of the job? Do think that is better or worse with the robot?

A Well, I don't know, because so far, since the robots been in. They put in the changeover in July, you know, the second week of July. Okay, since I have been back working with it, we haven't had complaints about water leakage. I don't know if it has or what, because when we had the sealer, that black stuff there was a lot of water leakage. There was something wrong there you know. But now since this robot is in, they don't, as far as I know, they don't come to be with complaints about water leakage, you know. Sometimes, I goes over there and check.

- Oh, you do check? You are that interested? You want to know what is happening?
- A Yea, because I feel like, um, I want to do my job good, you know what I am saying, and plus, I got a Ford product.

Q You do?

A Yea, I got a 85 Lincoln, and I feel like, um, you know, first I was buying other cars, but now I feel like since I work for Ford's I'll buy Ford products, you know. Bob told me that; he works on the line. He said why don't you buy a Ford product. You know, and I looked with my husband. I was gonna get a Riveria. And my husband said, since we work for Ford, he works next door.

Q Oh, he works at the car plant?

Uh huh. He said since we work for Ford, we'll just go and get a Ford car, and we can get the A plan and everything, you know. And I said I - really don't like what they got. - He said let's try the Towne-Car, you know. I said oh, okay. It was a luxury car and large.

That is a real luxury, luxury car?

A I said okay. Naw, I was taking the Ford, because when we travel we goes to like to Texas. He is from Texas.

Q Fort Worth?

Yea, and we go to Texas like two Christmas' we been to Texas. Well, no one Christmas and when his mother passed we went. So, ah, it rides

So by me working there, I wanted my quality job to be good and then plus I don't want no one coming and talking, you know, saying anything to me, you know. The better I work, the better I feel comfortable. Because if anyone comes and aggravates me, I be mad, you know. My whole day be ruined. Well, how to they aggravate you? Do you remember times when they used to aggravate you?

Yea, well, when we had this sealer stuff, that black stuff. They would constantly come over there. Like the men would over there from the garage, you know. So I guess the supervisors or something. And I quess this man would check for water leaks. He had a and he would write down how many water leaks were from my side, and so they check it, it would be like a lot of water leaks. Then they would come over there and they would say what is the problem. I would say there is not no problem, only thing I am doing is putting the stuff on there and it is up to the sealers it they want to seal so... So they tell me I said I can't nurse this job. When these trucks to rub it down. -start coming, I-cannot stay there and just nurse the job, you know. So I don't what the problem is. And, the majority of the time, the sealer has air in it, and that's not no good. Because the air, like it foams up.

Bubbles?

Yea, it bubbles up and you see it won't stick. You know what I'm saying? Because they have to have all the quality of the sealer there to make it stick like you know. So, doing this you know, they like

A Wait, let me tell you something. Okay, like I go out and check; they would tell me so much. You see, okay, so, um, they probably really not telling us. You know what I am saying? They put a \$25, uh \$50,000.00 machine in there, and this machine is taught to do it.

Is that what it cost, \$50,000.00?

I don't know. I think it cost that much, you know, \$50,000.00, you know. So, uh, they're not goin' to tell me if their really reaching or what. They probably come back and tell me, "take the tape and cover the holes" you know what I am saying? It would probably me my fault. Well, these people from the launching team, the launching team for the new truck. You know, like engineers and everything, they come in and check it out to see if they are properly being put together and stuff. So I was working and I am always talking and making conversation, you know, because I want to know, you know, who is who? Well, they have a badge; I looked, you know, and I asked them, I talked to them. I said "What is your job specialize in." The one walked on saying I specialize in sealer or something. I said "Oh, you specialize in sealer? He said yes, I am specializing any one of these new trucks. I got to find out where there coming from. I said "Oh yea". I said have you been getting water leaks from the door since they added the new machine in? He said yes. So, you know, he told me that, but they in the garage, you know, don't say nothing. Then, they bring in, like they introduce the people in labor relations, they introduce people in stock, they introduce people like, uh, different programs, like the E.I. committee man, you know. They was taking us in as brand-new. So, we went in the room. We discussed with the committee man, they told us what is what. I think this was, um, P.E.P. program.

Sealer all over the place, all over my shoes and people look at me and say God! You know I won't buy no new clothes. My housekeeper she gets mad with me. We was washing and the sealer would still be there. She say what is all this sticky stuff? I said, hey I'm not buying no new clothes, you know.

Q You don't wear coveralls?

A No. Ah ah, not coveralls. They make you too hot and then make you lose your feminine, you know?

Q Your what?

A Your feminen. It makes you look like a man in one of those. I'm already working like a man so I really don't, you know dress and look like one, you know. So I said oh God you got to make this better for

me. I said, I can't stand this, you know, it's like a pain. You know I hate to be nasty all the time. Everytime there's a party I gotta wash my hair and wash this stuff off. I couldn't gloves, you know. Why couldn't you wear gloves?

A 'Cause I had to pull the tape and the tape was sticking. Now I use them because I'm not using the sealer, and sometimes the sealer gets on your hands. It's just a mess, like you said you had experience with it, you know. It was just a mess, you know. When you work with gooky stuff, it gets in your mouth and it is nasty.

Q One of the reasons you don't wear coveralls is because you want to still hold onto your femininity?

A Well, that's my opinion.

- Q Your identity is important to you and that is what I want to talk about. Do the guys on the line relate to you as one of the guys? How do they relate to you?
- Well, my relationship with the guys is they relate to me as a woman. m A My relationship is like I, you know, closer like a sister image. You know what I'm saying? Like, um, it a fella come and try to talk to me... I'm married, I'm happily married. Like a fella come and try to talk to me I reverse it. I tell him well suppose your wife was doing this, you know, I break it down to him and they leave me alone. So I comes back with 'em like a sister image, you know. We qet a relationship in like а buddy, buddy, like a friend, friend That's how I want my relationship with the fellas in relationship. there. They real nice.

They respect you? They don't try to get on with you?

You show the type of people you is, you lay it out on the line you know. And then, they, they, okay, I'll say like a 'xample like Jack. Jack Holmes he works on the trim. He had gotten pretty bad himself, but it was like I will deal with their mind; I reverse that thing, because it's like, um, he started making the insinuation-like racial like you know.

Q What kind of things?

Like, uh, B.J.... Well first of all like Detroit. You know, like a whole lot of 'em don't like Mayor Young, okay. So... um, you know they say little aggravations, you know. I guess what used to get me fired is I used to...

Q What kind of things would they say?A Well, like, uh, Mayor Young is prejudice against them and stuff you

So, uh, they don't like that 'cause I tell 'em like it is, you know. So, uh, I tell Jack, I say Jack I said well... He made this comment he said you people you know. But you are starting to see what I'm saying about him and coming from. You people my father, my grandfather owned one of you. I said oh yea, and guess what? This is 86 baby, I said look, I said you here, I'm here we making the same money, I said I will probably have your granddaughter doing my housekeeping work you know? He look, you know, I turn his head around, you know I get 'em wear it hurts, you know. So they can just come off of it and then I come back as a sister image. Because all of us in this together, you know what I'm saying. We making the same thing, the same bucks, we got the same income, you know. And, I have to break 'em down again another time he kept throwing the insinuation like ah... Like ah, B.J., um, like he's downing me, you know what I'm saying. I had to cut him off, I said hey look.

Q What did he say?

It was something about, um, something about, um, I don't have, you

know, ah, it was something about he was downing me 'cause I was black you know what I'm saying, you know. It was something, you know, so I 1 just stopped right there. I didn't say it in front of everybody, I wispered in his ear, I said you know what Jack? I said, I work in the 團 factory, my husband works in the factory, I said I got just as much as you, or more. So you might as well cut the bullshitting out, 'cause we we might as well work together and be for real people I said get that 5 out of your head, you know. He looked at me, you know, so ever since then, um, he hasn't came to that role with me that we talked about. . Ι don't know, they probably tease with other people, but I lay it down a) because I don't want to tease 'cause it's enough problems in there. So, um, you know, he left that alone. He started off with that believe B or not, but not know. Just like they pick with 'em and stuff, and I say Jack I love you, and he thank you B.J., you know. So, you know, I turn it around into something like love you know which it all boils 喇 down to you know. We in this together, we have to work together and have a happy atmosphere 'cause it's already rough, working mentally and physically for the factory. You know what I'm saying so us brothers, uh, sisters, and the union we gots to you know we have to make this 8 thing work comfortably, you know. And so...

Q You hired in 77 about 10 years ago, what do you think that kind of testing segmenting the whites in the plant and that kind of sort of thing? Do you think that it has gotten better or worse?

A It's still there. You can feel the vibes, it's still, you know I noticed, um, too, like, um when I first got hire in there ain't really caring too much about a black woman, you know. Black woman is in

So, I was hanging in there, in there on that job and stuff. Probably messing a couple of things up, but I was hangin' there you know. It wasn't no reason to fight. So they just fired me. Were you carrying instrument panels in and putting the wires on the

instrument panels?

No. I was working in chasis then. I was doing the splasher job.

Q The what job?

The splasher job. This job is like ah, I had to run about fifteen screws to put on one side of the truck and it was like, it was up there by the battery job, okay. It was like I had to shoot the mud splasher. Underneath the tire that rubber thing?

Yea. And I had to shoot the screws in. A whole lot of little screws. I had to use these screws to put everything, you know, screw 'em up, you know. So, uh,... The reason why they fired me was because they wanted to get rid of the woman. They got rid of two white woman and one black, that was me. They got rid of us. So, uh, I say well I tried, you know, so, uh, Jeff he tried to get in touch with me because

He said girl we been trying to get in touch with you. We been trying to bring you back to work. I said what? He said yes because it wasn't your fault they fired you. So he said come on in here so we can take of

this. I said okay. So I came in, they paid me for the whole time. Really?

When you say that there was this closeness, would you get high when you got there at five o'clock in the racks, what would it be like?

They think it's crazy, but you know ain't nothing. My husband and I agree I work and he works. And we agree that we going in half to pay for one to come in and help me clean up you know.

Q Why does someone like Smitty think it's so...

A Because um...

Q How do you react to it?

A How do I react to it. It blew his mind. You know, somebody working in here got a housekeeper someone to help her. It blew his mind 'cause I don't believe he have one. You know what I'm saying. That's why it blew his mind, especially me, B.J. you know.

Q A young black woman?

A Yea. B.J. a black woman? You know it's not normal you know. You know the white people do; they have 'em you know. It's not normal. When I was laid off and I was drawing my unemployment I went out there and I was housekeeping. That's mostly I worked. I worked it for Jews. You know this Jew lady name Ms. Silver and me and her is like this you know even today. 'Cause I love her and she loves me and she stayed in Bloomfield Hills. Beautiful home, her husband is a doctor in Detroit Medical Center. And um, right now today I'll call her and wish her happy Hanukkah and she call me and send me cards and stuff you know. You know so um, not nothing wrong with that so I got experience of housekeeping so it's not nothin' wrong with it.

Q It's a respectful relationship.

Right, right, right, so it shocked 'em. A black woman has somebody else you know and stuff you know. It ain't bother me. Like she um she um keeps my kitchen clean and my floor. She irons me and my husbands

See because I got this trust with these people you know and so, by they trust me you know we can move a rate. Because my sister she works out in Bloomfield Hills and I gave her a lady who stay in Franklin I used to do. I had my thing set up. I would like work for Ms. Silver for three days a week and then on Tuesdays and Thursday, I would go to this other lady's house. I would get through and come on back home that was my money. I was making like um let me see... I made \$108 from Ms. Silver and \$35.00 from Ms. Landoff, this is tax-free.

Q Under the table?

Yea five a days a week and it was good you know because I wasn't gettin' unemployment or nothin' you know. So it was good. So I didn't want to let it go so I turned it over to my twin. So she got it like in control. But, we trying to get somethin'. We trying to get a building or something. I'm looking for something besides the factory. 'Cause the factory might fall. You know, you can't depend on that. I'm going by what my talent is, what I can do. Factory is all right. Factory is security and everything you know. So, I went back to work, my husband asked me, he said um, you sure you can handle it? You know, um, I wasn't working when me and him was married. I was working a little bit and laid off and stuff, and he asked me he see how much work was around here. He liked what I was doing you know. I said oh yea... I was geeked up. You know I wanted to go back and make this money so

I get up at 4:20, ah 4:35, and um, I leave here, it takes me twenty-five minutes 'cause I done and took my shower and everything. Just wash up probably drink me a cup of coffee. Okay and put my

clothes on. I leave here at 5:00. I get to work 5:30. You know it's my hardest time... Getting up. Getting up, and if I don't have the proper rest and sleep, it be really hard for me.
